AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE SECTION ROAD LATERAL; FIRETOWER ROAD LATERAL; TWO HIGHWAY 1078 LATERALS; COUNTRY CLUB DRIVE LATERAL; HIGHWAY 433 LATERAL; BENJAMIN ROAD LATERAL; COIN ROAD NORTH; AND TO RENAME A PORTION OF EXNICIOS DRIVE AS PADOC RANCH ROAD. WARDS 2, 3, 4, 8 & 9, DISTRICTS 2, 3, 4, 5, 6 & 11

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Section Road Lateral (#D02PW01003), approximately 450 feet, located northwest from Section Road (R02P003) and ending at a pond, Ward 2, District 6; and
2. Add Firetower Road Lateral (#D04BW01003), approximately 400 feet, located south from Firetower Road (R04B003) and ending at Lazy Creek Subdivision, Ward 4, District 5; and
3. Add Highway 1078 Lateral (#DHL1078W001), approximately 1,515 feet, located south from Highway 1078 (HL1078) along the west side of Slatchery Road (private), Ward 3, District 3; and
4. Add Highway 1078 Lateral (#DHL1078W002), approximately 1,515 feet, located south from Highway 1078 (HL1078) along the east side of Slatchery Road (private), Ward 3, District 3; and
5. Add Country Club Drive Lateral (#D04AW03011), approximately 3,300 feet, located west on the north side of Country Club Drive (R04A011) and ending at the river, Ward 4, District 4; and
6. Add Highway 433 Lateral (#DHL433W001), approximately 700 feet, located northwest from Bayou Liberty Road (HL433), Ward 9, District 11; and
7. Add Benjamin Road Lateral (#D09HW01008), approximately 300 feet, located south then east from Benjamin Road (R09H008), Ward 8, District 11; and
8. Add Coin Road North (R03F105), approximately 900 feet, located north from Coin Road (R03F005), Ward 3, District 2; and
9. Remove a 1,330 feet portion of Exnicios Drive (R02X014) and rename that portion as Padoc Ranch Road (R02X022); additionally adjust the road data for Exnicios Drive to reflect the removed length.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
