ORDINANCE APPROVING AND AUTHORIZING THE EXECUTION OF A SALES TAX ENHANCEMENT PLAN BY AND BETWEEN ST. TAMMANY PARISH GOVERNMENT, ST. TAMMANY PARISH SALES TAX DISTRICT NO. 3 AND THE CITY OF SLIDELL FOR THE SHARING OF SALES TAX REVENUE GENERATED ON ANNEXED PROPERTY

WHEREAS, St. Tammany Parish collects a two cent sales tax for road and drainage infrastructure improvements, maintenance and facilities within the boundaries of Sales Tax District No. 3; and

WHEREAS, the City of Slidell collects a two cent sales tax within the municipal boundaries of the City; and

WHEREAS, the City of Slidell periodically annexes property, at the request of the property owner, into the city limits in order to provide city services to the property; and

WHEREAS, the Parish and the City believe that the imposition of sales taxes in annexed areas by both the Parish Sales Tax District and the City of Slidell may discourage business growth, adversely affect land use planning and subject parish citizens to increased taxation on the purchase of goods and services; and

WHEREAS, Parish Government believes a sales tax sharing plan is essential to insure the continued development of business in St. Tammany Parish and the orderly and appropriate planning and development of land in both the Parish and the City of Slidell.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it approves and adopts the hereto attached Sales Tax Enhancement Plan by and between St. Tammany Parish Government, St. Tammany Parish Sales Tax District No. 3 and the City of Slidell.

BE IT FURTHER ORDAINED that the President of St. Tammany Parish, Kevin C. Davis, is hereby authorized to execute the Sales Tax Enhancement Plan with the City of Slidell on behalf of St. Tammany Parish Government and St. Tammany Parish Sales Tax District No. 3.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not effect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
