ORDINANCE TO RENAME E. FAIRWAY DRIVE AND ITS FUTURE  
EXTENSION AS JUDGE TANNER BOULEVARD

WHEREAS, East Fairway Drive currently runs from U.S. Highway 190 east to Westwood Drive;  
and

WHEREAS, the proposed East Fairway Drive Extension, which is currently unopened, extends  
from Westwood Drive to La. Hwy. 1088; and

WHEREAS, the late Judge Thomas Wesley Tanner, retired as Chief Judge of the Twenty-Second  
Judicial District Court for the Parish of St. Tammany, State of Louisiana, and thereafter served, by  
appointment of the Louisiana Supreme Court, as Ad Hoc Judge of the 18<sup>th</sup>, 21<sup>st</sup> and 22<sup>nd</sup> Judicial District  
Courts and the First Circuit Court of Appeals. Judge Tanner was a U.S. Army Veteran, 82<sup>nd</sup> Airborne, past  
president of the Louisiana District Judges Association, former Chairman and Vice Chairman of the Law  
Enforcement Commission, and first President of the Slidell Chamber of Commerce; and

WHEREAS, in honor of Judge Tanner's distinguished service to the residents of St. Tammany  
Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

SECTION I. To rename East Fairway Drive and future Extensions, from U.S. Hwy. 190 to La.  
Hwy. 1088, as Judge Tanner Boulevard.

SECTION II. The Department of Public Works is directed to obtain and place the appropriate street  
signs to so designate the road as indicated above.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity  
shall not affect other provisions herein which can be given effect without the invalid provision and to this  
end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
