RESOLUTION OF INTENTION OF THE PARISH COUNCIL TO ABOLISH SEWERAGE DISTRICT NO. 6, ORDERING AND DIRECTING DUE NOTICE OF THE PROPOSED ABOLISHMENT AND SETTING A HEARING DATE FOR ANY AND ALL OBJECTIONS THERETO, AND TO PROVIDE FOR ALL OTHER MATTERS IN CONNECTION THEREWITH. (WARD 3, DISTRICT 3)

WHEREAS, the Parish Council, on its own initiative, desires to issue notice of intention to abolish Sewerage District No. 6 in the Parish of St. Tammany, in the manner provided for by Chapter 9, Title 33 of the Louisiana Revised Statutes, and other Constitutional and statutory authority supplemental thereto.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES, through its Parish Council, acting as the governing authority, that:

SECTION 1. In compliance with the provisions of Sub-Part A, Part I, Chapter 9, Title 33 of the Louisiana Revised Statutes, and other Constitutional and statutory authority supplemental thereto, it is the intention of the Parish of St. Tammany, State of Louisiana, to abolish Sewerage District No. 6 within the Parish of St. Tammany, outside the corporate limits of any municipality, and generally encompassing that area east of Covington and west of Abita Springs.

SECTION 2. The Parish Council of the Parish of St. Tammany, State of Louisiana, shall meet in open and public session in Council Chambers, 21490 Koop Drive, Mandeville, Louisiana, on Thursday, November 5, 2009 at 6:00 p.m. for the purpose of hearing any and all objections to the abolishment of Sewerage District No. 6, and that after disposing of all objections, the governing authority shall, if it determines to do so, adopt an ordinance to abolish said Sewerage District.

SECTION 3. The Parish Council hereby orders and directs the issuance of a notice of intention of the Parish Council to abolish said Sewerage District, which notice shall embrace substantially all things set forth in this resolution and shall be published in accordance with law.
