The participant agrees to indemnify and hold harmless St. Tammany Parish Commission on Cultural Affairs and St. Tammany Parish Government from any and all actions taken by the participant and/or any person associated with the program and against any and all claims participant may have arising from the acts of third parties or acts of God under said agreement.

Participant and St. Tammany Parish Government both agree to indemnify, hold harmless and defend each other, and their respective officers, agents, servants, attorneys and employees from and against any and all claims, demands, losses, suits, damages, judgments, costs and expenses whether, indirect or consequential and including but not limited to all fees, expenses and charges of attorneys and other professionals, as well as court costs and expenses, for actions or inactions arising out of, in connection with, or resulting from, the performance of services hereinafter arising from claims or violations resulting from such services performed in the course and scope this agreement.

These entries must be approved by the principal of the school and Channel 13. Once approved, Channel 13 will forward entries to film competition officials.
